



**FRIO COUNTY IS OFFERING a \$100 Cash Incentive to Encourage Frio County Residents to get Vaccinated Against COVID-19**

As part of our efforts to increase the number of Frio County residents who are fully vaccinated against COVID-19, Frio County will offer **\$100 cash** to residents who become fully vaccinated against COVID-19 between September 14 and October 30, 2021.

The cash incentive will be given to individuals who receive a full dose of any COVID-19 Vaccine (Moderna, Pfizer or Johnson & Johnson) at any Health Provider of your choice. Residents are eligible to receive \$100 incentive only if vaccine series is started and completed during the applicable time period. Eligible minors must be accompanied by their legal guardian. **People who are already fully vaccinated are not eligible for the incentive.**

“We will do whatever we can in this fight against COVID-19 to help keep our residents safe and to prevent the virus from spreading further in our community.”

Authorization forms must be picked up at the County Judge’s office between 8:30 a.m. and 3:00 p.m.

## VACCINE INCENTIVE PROGRAM

Beginning September 14, 2021 thru October 30, 2021 Frio County Residents not vaccinated for COVID-19, will be eligible for up to a one-time \$100 incentive for getting a required dose of COVID-19 Vaccine.

The incentive will only be made this one time. This completed form **MUST** be returned by November 30, 2021 to receive incentive pay.

To be eligible, you must comply with all guidelines set for the program as indicated below:

Must register at Frio County Judge's office Monday – Friday, 8am-noon 1pm-5pm  
Located at 500 E. San Antonio St., Pearsall, Texas 78061 ph.830-334-2154  
Picture ID required or proof of Frio County residency.

Participants must be at least 12 years of age.

Participants under the age of 18 will require written permission from a parent and or guardian before incentive will be disbursed.

No more than one \$100 incentive will be distributed per person upon proof of full vaccination.

You may be vaccinated by any provider of your choice. Take this form to the provider to complete and return to Frio County to receive incentive.

Funds are being made available through the American Relief Program received by Frio County. Proof of vaccination must be provided before disbursement of any funds.

I understand and agree that when opting in to receive this incentive, my vaccine information will be shared with state and federal agencies other than the Department of Health. I further understand that these entities are not covered entities and not subject to the same HIPAA privacy requirements and protections as a covered entity such as the Department of Health. I hereby permit my vaccine information to be released to the entities described above for the limited purposes of confirming my vaccine status and to process the vaccine incentive. I further release Frio County of any and all liability that may arise after receiving the vaccine. **I also certify that I have not already received any of the vaccines available for Covid-19.**
